Dear Ms Pavlenko,

I have the honour to thank you for your letters concerning the voluntary donation raised through the “Urgent Energy Solidarity with Ukraine” campaign and for the support of the Embassy of Ukraine in the Kingdom of Spain, the Ukrainian community in Spain, AGA-UCRAÍNA and the participating Spanish organisations.

The Energy Community Secretariat is pleased to accept the contribution of EUR 30,595.57 to the Ukraine Energy Support Fund (the Fund), to be transferred by Asociación Galega de Axuda a Ucraína – AGA-UCRAÍNA.

The contribution will be accepted on the following conditions:

1. AGA-UCRAÍNA will be regarded as the sponsor of the contribution, acting as the entity transferring the funds collected through the campaign.
2. The contribution will be transferred irrevocably and unconditionally to the special purpose account maintained by the Energy Community Secretariat for the Ukraine Energy Support Fund.
3. The contribution will be administered as a non-earmarked contribution and may be pooled with contributions from other sponsors for the provision of necessary support to eligible Ukrainian counterparties in accordance with the applicable arrangements of the Fund.
4. The contribution will not be used to finance military activities.
5. No management or administrative fee will be deducted from this contribution.
6. Any interest generated by the special purpose account will form part of the resources available under the Fund, while related banking costs and charges may be covered from the Fund.
7. The contribution will be administered in accordance with the fiduciary, confidentiality, liability, refund and other conditions generally

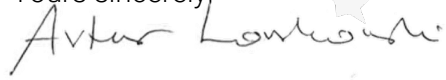
